OUR EMPLOYMENT SOCIAL ENTERPRISE (ESE) IS A STAFFING AGENCY WITH A DUAL FOCUS: CONNECTING INDIVIDUALS WITH MEANINGFUL EMPLOYMENT WHILE CONCURRENTLY ADDRESSING AND ELIMINATING THE VARIOUS BARRIERS PERPETUATING THE GENERATIONAL POVERTY. IN 2024, 841 INDIVIDUALS CONNECTED WITH AN EMPLOYMENT NETWORK OF 130 EMPLOYERS, WORKING 17,721 SHIFTS THROUGHOUT THE GREATER SEATTLE AREA. THIS RESULTED IN 146,703 HOURS OF WORK AND TRAINING, WHICH GENERATED \$3,436,519 MILLION IN WAGES IN OUR LOCAL ECONOMY.

IN 2024, THESE EFFORTS RESULTED IN 358 JOB TRAINING CERTIFICATES FROM 1,116 CLASSES ATTENDEES IN OUR ULNW LEARNING CENTER. WE PROVIDED A TOTAL OF \$210,419 IN SUPPORT SERVICES THAT COVERED ESSENTIAL NEEDS SUCH AS EYE CLINIC SERVICES, EDUCATIONAL SUPPLIES, PPE, COMMUNITY MEALS, WORKER CLOTHING, HYGIENE PRODUCTS, AND ACCESS TO SHOWERS.
